

Be it enacted by the Senate of Emory & Henry College

This bill hereby clarifies and reorganizes the current governance of Emory & Henry Student Media.

- I. This bill hereby establishes the Emory & Henry Publications Board (Constitution attached).
 - A. By establishing the Emory & Henry Publications Board, the Student Government delegates governance of student media to the Publications Board as specified in the Board's Constitution. This includes:
 - 1. The hiring and firing of student media chief officers
 - 2. The review and approval of each media organization's governing document to be kept on file with the Board.
 - B. The College Senate must approve any Amendments to the Constitution of the Emory & Henry Publications Board.
- II. This bill hereby establishes the Emory & Henry Media Guidelines (attached) as the College's general policy concerning campus media.
 - A. Amendments to the Emory & Henry Media Guidelines requires the approval of the Emory & Henry Publications Board, the College Senate, and the President of the College.
 - III. The Emory & Henry Media Guidelines shall be included in the Student Handbook and Calendar and circulated to all students.



Senate Bill # 126



Senate Bill #127

- I. The four-day rule currently requires all legislation to be given to the Senate Clerk four days before a College Senate meeting.
- II. This bill shortens the four-day rule to the 36-hour rule, whereby all legislation to be considered at the next senate meeting shall be given to the Senate Clerk at least 36 hours before the meeting.
- III. The Senate Clerk shall then have all legislation posted to the portal a minimum of 24 hours before the senate meeting to allow Senators adequate time to consider the legislation before it is presented.
- IV. If particular legislation does not meet the 36-hour rule, the rules must be suspended by a vote of the College Senate in order for that legislation to be considered.


