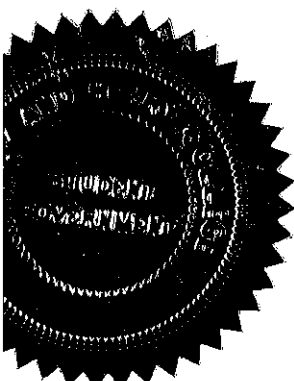
**SENATE BILL # 136**

### Senate Bill # 137

Be it enacted by the Senate of Emory & Henry College

This Bill hereby establishes an ad hoc Honor Committee within the Student Government of Emory & Henry College.

*Whereas* Emory & Henry, as a liberal arts institution, is dedicated to providing its students with the best in higher education and as a college community continually strives to improve academic prestige; and  
*whereas* creating an honor system that is effective and credible in which all persons in the academic community pledge in seriousness and sincerity greatly aides one's educational experience; and  
*whereas* currently the Emory & Henry Honor Code is insufficient and is not taken seriously by all persons in the Emory & Henry community; and  
*whereas* members of the academic community have expressed dissatisfaction with the Honor Code and dissatisfaction with the manner in which infractions of the Code are handled by Emory & Henry College;

Therefore be it enacted by the Senate of Emory & Henry College,

A. The Student Government of Emory & Henry College shall establish an ad hoc Honor Code Committee consisting of Student Government representatives from the student body, faculty, staff, administration, and judicial. The duties of the committee shall consist of, but not be limited to, the following:

1. To examine the current Honor Code.
2. To examine the manner in which it is currently and in the past has been enforced.
3. To conduct research into the Honor Code of Emory & Henry peer and aspirant institutions.
4. To report periodically to the Senate on the committee's progress and discoveries.
5. To present to the Senate before the last session of the 2004-2005 Senate final recommendations in Bill and/or resolution format to improve the honor system at Emory & Henry College.

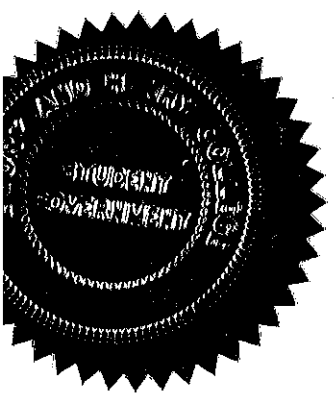
B. Upon passage of this bill, the Senate shall vote on the members of the committee;

**Senate Bill #138**

This bill hereby approves an operating budget for Student Government for the spring semester of 2005.

- I. Guidelines set and used by the Executive Finance Committee and the Senate Finance Committee.
  - A. Conferences, trips, etc. capped at \$75 per person for up to 10 people.
  - B. Food requests capped at \$100.
  - C. Requests for t-shirts, cords, keys, etc. capped at \$150.
  
- II. The Ampersand, for the time being, will be cut \$2,000 from printing costs until the full amount can be verified. If verified, the \$2,000 will be placed back in their accounts and otherwise it will be placed in the Student Government's reserve and distributed to other organizations as the Senate sees fit.
  
- III. The budget that follows shall take effect immediately.

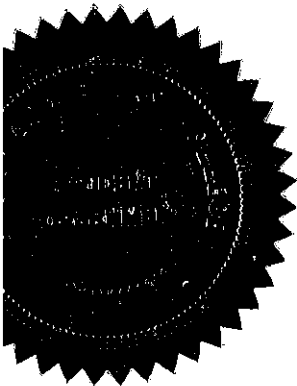
### **Senate Bill # 139**

Be it enacted by the Senate of Emory & Henry College,

This bill hereby establishes the 2004-2005 Student Government Honor Commission

- I. The purpose of the Honor Commission will be:
  - a. To examine the current Honor Code at Emory & Henry College.
  - b. To study the implementation of the Honor Code.
  - c. To examine the manner and mechanisms in place to enforce the Honor Code.
  - d. To research the Honor Code at peer and aspirant institutions.
  - e. From this examination the Honor Commission should formulate a proposal under the guidelines of Section IV of this bill.
  
- II. The makeup of the Honor Commission shall be as follows:
  - a. Representing the College Senate: Three senators, two of which must be student senators.
    - i. Upon passage of this bill, the Senate shall choose the three senators to serve on this commission by a majority vote on each nominee.
    - ii. Once College Senate members are in place, a co-chair from among them should be appointed by the President of the student body.
  - b. Representing the Student Body: Four students at large to be chosen by the College Senate; one representing each class.
    - i. The students chosen by the student body should not be members of Student Government.
  - c. Representing the Faculty: Two faculty members at large to be chosen by the Dean of Faculty.
    - i. The Faculty chosen should not be members of Student Government.
  - d. Representing the Administration: One member of the administration chosen by President Morris
  - e. Representing the Executive and the Judicial: Chief Judicial Officer Caci Lamb, Judicial Officer Megan Mullins, and Judicial Officer Scott Sutton
    - i. These members will only be able to cast one vote between the three of them.

- ii. The Chief Judicial Officer will serve as a co-chair of this committee along with one of the senators chosen under Section II; subsection a, subsection i of this bill.
  - f. The Honor Commission will also have the ability to replace members of the commission by a majority vote.
- III. This commission will report to the College Senate at every Senate meeting on the Honor Commission and its progress. It will also be responsible for collecting the data compiled through out its work. One of the commission members, who is also a member of the College Senate, will present any proposal or bill outlined in Article IV of this bill.
- IV. At the April 20<sup>th</sup> Senate meeting the commission will either:
- a. Present a proposal/bill outlining recommended changes to the Honor Code and the honor system at Emory & Henry College
  - b. If the feeling of the commission is that a proposal/bill would not be wise at this time, the commission should craft a bill stating that the Honor Commission continues its work under the next Senate.
  - c. Under this option, the commission will also prepare a year-end report to be presented to the Senate and passed on to next year's Honor Commission.

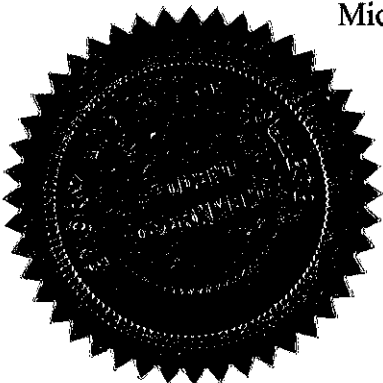

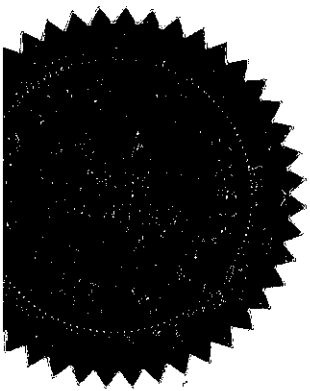

Be it enacted by the Senate of Emory & Henry College,

**Section I.**

(i) Purpose – The Department of Administrative Affairs shall serve to structure, oversee, and supervise all elements of formal interaction and communication between the Student Body, Student Government, and the Administration of Emory & Henry College.

(ii) Structure – The Department of Administrative Affairs shall be composed of the Administrative Affairs Officer, the Administrative Affairs Committee (if applicable), and the President of Student Government.

**Section II.**

**(i) Administrative Affairs Officer**

a. Appointed by the President of the Student Government and approved by the Senate.  
(See Constitution Article IV.D)

b. Appoints, when necessary, an Administrative Affairs Committee.

c. Chairs the Administrative Affairs Committee.

d. Determines a just, efficient, and appropriate way to approach communication with the Administration and the Student Body, and hence communicates with the Student Body, Student Government, and the Administration of Emory & Henry College.

e. Provides an available line of communication between the Student Body, Student Government, and the Administration of Emory & Henry College.

**(ii) Administrative Affairs Committee**

a. Appointed by Administrative Affairs Officer and approved by Senate.

b. Works to help organize, improve, and facilitate communication efforts between the Student Body, Student Government, and the Administration of Emory & Henry College.

c. Evaluates all plans of formal communication.

**(iii). President of the Student Government**

a. Oversees all formal communication between the Student Body, Student Government, and the Administration of Emory & Henry College.

b. Provides an available line of communication between the Student Body, Student Government, and the Administration of Emory & Henry College.

**Senate Bill No. 149**

This bill hereby provides for a temporary adjustment to the constitution of the Judicial Board, Appellate Council and Central Judicial Council under the Judicial Code.

Be it enacted by the Senate of Emory & Henry College,

**The Composition of the Judicial Branch**

- I. A total of nine Student Judicial Councilors shall be appointed by the President of the Student Body and approved by the Senate. The Judicial Board, Appellate Council and Central Judicial Council shall draw from this pool of nine councilors as needed. Any Student Councilor chosen to have initial jurisdiction of a case shall not be allowed to hear any of the subsequent appeals, and any Student Councilor chosen to hear a first appeal shall not be allowed to hear a final appeal. If a conflict of interest occurs and there is a deficient number of Student Councilors to hear an the initial jurisdiction or appeal, then the President of Student Government has the right to appoint a Student Judicial Councilor. The President also has the right to appoint a Student Investigator if necessary.
- I. Initial Jurisdiction
  - A. Judicial Board
    - i. The responsibilities and requirements of the Judicial Board shall be the same as found in Senate Bill #96, article II, section A, subsections i and iii-vii.
    - ii. The Judicial Board shall be composed of three students from the nine Senate-approved Student Councilors appointed by the President of the Student Body, two faculty members and two administrative members. The Faculty and Administrative Councilors will be appointed as provided in Senate Bill #96, article II, section A, subsection ii.
  - B. Administrative Hearing Option
    - i. See Senate Bill #96, article II, section B.
- II. Appellate Jurisdiction
  - A. Appellate Council
    - i. The responsibilities and requirements of the Appellate Council shall be the same as found in Senate Bill #96, article III, section A, subsections i and iii-v.
    - ii. The Appellate Council shall be composed of two students from the nine Senate-approved Student Councilors appointed by the President of the Student Body and one faculty member. The Faculty, as stated in Senate Bill #96, article III, section A, subsection ii, will appoint the Faculty Councilor.



**B. Central Judicial Council**

- iii. The responsibilities and requirements of the Central Judicial Council shall be the same as found in Senate Bill #96, article III, section B, subsection i as well as those found in the Student Government Constitution Article VIII, section 2.
- iv. The Central Judicial Council shall be composed of three students from the nine Senate-approved Student Councilors appointed by the President of the Student Body, one faculty councilor elected by the faculty and one administrative councilor appointed by the President of the College. Each appointing body shall determine terms for Faculty and Administrative Councilors.

- B. gather opinions on campus dining and make recommendations if needed;
- C. evaluate activities available to students on campus and make suggestions for new activities;
- D. seek the opinion of the overall student experience, including but not limited to academic life, academic buildings, extracurricular activities, etc.

**II. Membership**

The members of this committee shall be chosen at the first Senate meeting of each year by the Presiding Officer, the Student Government President and Cabinet members.

Be it resolved, a resolution expressing the sense of the Senate as to necessary parking improvements to accommodate the growing Emory and Henry community.

*Whereas*, the Housing and Grounds committee has complied with Senate Resolution #155, and is in agreement with the Student Life Committee, and,

*Whereas*, the following problems have been observed concerning the current campus parking accommodations that include but are not limited to:

- I. There is a documented lack of parking availability for commuting students.
  - a. 317 commuting students
  - b. 193 commuter parking spaces
  
- II. There is a lack of parking availability for visitors, who in turn take spaces from assigned parking of students; these include but are not limited to:
  - a. Athletic event spectators
  - b. Fine arts events
  - c. Prospective students
  - d. Golfers
  - e. Church events
  
- III. There is a documented lack of parking availability for Hillman residents:
  - a. 137 Hillman residents
  - b. 98 available parking spaces
  
- IV. The parking lot at Stuart residence hall is in dire need of corrective attention.
  
- V. The Wiley-Jackson Hall overflow lot is overcrowded.
  
- VI. There is a documented lack of parking availability for Sullins Hall residents.
  - a. Capacity for 32 students
  - b. 22 available parking spaces

VII. Parking areas are not sufficiently labeled consistently across campus.

**Therefore, now, be it resolved,** the Senate of Emory and Henry College expresses its sense that the above problems need to be addressed. To that end, the Senate makes the following recommendations:

- I. A large, paved parking area should be constructed in an inconspicuous location that does not detract from the aesthetic beauty of the campus. Possible locations include the areas behind Martin-Brock and the athletic practice fields.
- II. The Hillman gravel lot next to the Post Office should be paved and striped and expanded north to enable a more efficient means of parking.
- III. The Stuart Hall parking lot should be considered for extreme renovation.
- IV. The Wiley-Jackson Hall overflow lot should be paved, striped and expanded to exceed current conditions.
- V. The Sullins Hall lot should be paved and striped for more efficiency. The lot should also be expanded west for additional spaces.
- VI. Each parking area should be labeled in a manner that is easy to view and comprehend. For example, spaces should be labeled with a permanent and obvious marking. This marking should be no smaller than 12" x 8".

**Resolved,** the Senate recognizes that this list is not all inclusive.

**Also, resolved,** the Senate urges the Administration to implement these recommendations as well as others to improve the current parking conditions.

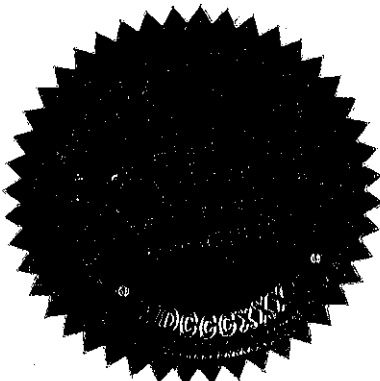

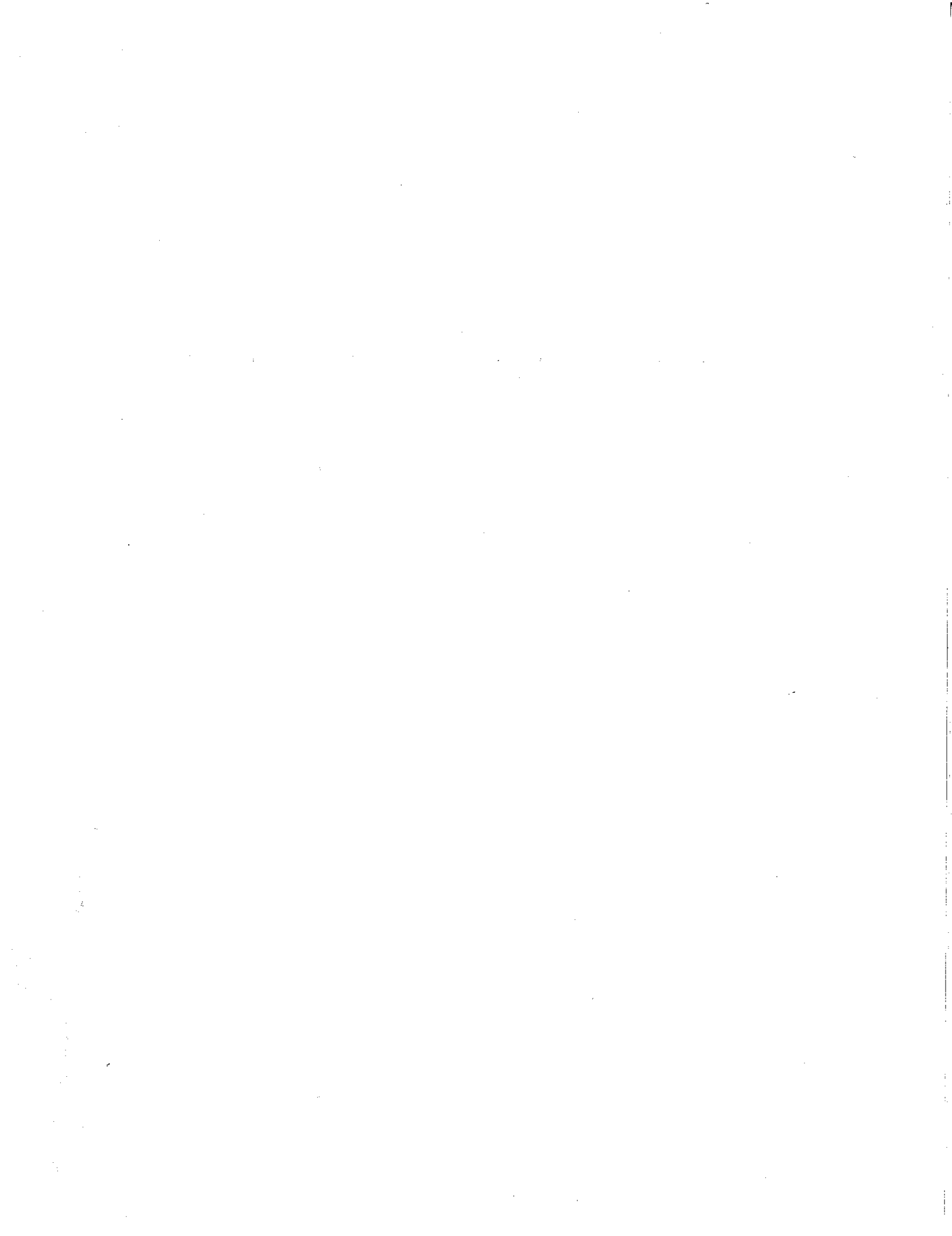

The budgetary process automatically creates a strong relationship between Student Government and the wellbeing of other student organizations. It is important that this committee, while working closely with the treasurer, maintains equality during the distribution process. Any general rules which are used to explain how money is distributed should be clarified to both the Student Senate and student organizations.

The chair of the Finance Committee should hold regular meetings with the Student Government treasurer so that there is no confusion during these processes. Each member of this committee should always have the budgetary information ready in case any questions arise during Student Government meetings. Also, each member should eagerly participate during these processes and should not be absent during official meetings.

### Rules Committee

It will be the duty of the Rules Committee to be well-versed and committed to the rules and procedures of Student Government.

Any changes to the rules should be implemented through the Rules Committee by legislation. It is also the duty of this committee to address controversies during Senate meetings that concern the rules and procedures of Student Government. The chair of this committee should act as an arbiter during disputes or controversies that arise between senators; however, the rules should be enforced equally to all members of Student Government. It is very important for members of the Rules Committee to address contradictory and debilitating rules which might hinder the effectiveness of official meetings.

Most members of the Rules Committee should have experience in Student Government. This is important because a comfort with the rules will allow for effective leadership within the Senate. Senators should come to the Rules Committee if they have any suggestions or concerns regarding the effectiveness of Senate procedures.

## Organizations Committee

The Organizations Committee will oversee and manage any organization during its quest to be chartered through Student Government, and it will serve at an intermediary between Student Government and any chartered student organization. This committee should provide future organizations with a detailed description of what is needed in order to become chartered through Student Government and be able to address any problems that a potential organization might have.

The Organizations committee will serve as a contact when student organizations have questions or concerns regarding Student Government. Furthermore, when student organizations violate or ignore the rules on which they were chartered, and if an organization refuses to adhere to Student Government's requests, it is the obligation of this committee to supervise the dispute and recommend to the Senate any actions that should take place.

This committee should work closely with the Finance Committee during the budget process. This may include, but is not limited to helping organizations understand how to submit acceptable budget requests or aiding them when they are unable to attend Senate budget meetings. The burden still falls on the organization, but this committee should be there to support organizations that are in need.

## Housing & Grounds Committee

It is the duty of the Housing & Grounds Committee to remain updated on the current development and upkeep of Emory & Henry's facilities and land. They may work with the Student Life Committee when seeking information on student perceptions of dormitory situations. Also, the Housing & Grounds Committee should work with the College's faculty and administration when analyzing the academic facilities, as well as any general concerns with the College's land use.

The Housing and Grounds Committee should have a deep understanding of current facility, dormitory, and projects which affect the grounds of Emory & Henry. This committee should include pictures, descriptions, and details when presenting their findings to the Senate and the Student Government president. Thorough walkthroughs of problem areas should be implemented, and a complete evaluation should accompany any suggestions that this committee wishes to present.

The chair of the Housing & Grounds Committee should meet with the College's administration, in accordance with the Student Government president, when health risks

or concerning issues are found within the College's housing and grounds. Moreover, this committee should seek out reasonable actions that could help repair such problems. It is important that findings are detailed and accurate. The Student Government president should use the findings of this committee and present them to the College's Board of Trustees as needed.
