

SENATE BILL #40

The following is a measure to amend the Greek Council Constitution.

Be it enacted by the Senate of Emory & Henry College,

- Greek Council By-Laws, Section 8 shall read:

- "B. Each Greek Organization must submit their definition of and policy toward honorary members to be
 - 1. The sisters of Alpha Beta Chi extend honorary membership according to the following guidelines:
 - a. must be approved unanimously
 - b. can at no time have more than two honoraries
 - c. privileges of honoraries:
 - may attend meetings and activities of the sorority,
 - ii. may participate in all sporting activities,
 - iii. may not be required to pay dues, but should pay fees for other sorority events,
 - iv. may not be required to participate in any money making activities,
 - v. may not vote at any meeting,
 - vi. may become a full sister by participating in the initiation period as set up by the Greek Council,
 - vii. may not wear the ABX pin or crest,
 - viii. may not attend formal initiation
 - d. may not be nor become a member of any other Greek organization at Emory & Henry College i. must be notified of this stipulation prior to becoming a honorary member.
 - 2. The brothers of Beta Lambda Zeta do not accept honoraries.
 - 3. The sisters of Delta Omicron Pi extend honorary status as they see fit. Delta Omicron Pi allows their honorary sisters the same privileges and rights as all other sisters of the sorority.
 - The sisters of Delta Rho Delta extend honorary membership according to the following guidelines:
 - a. shall not have the privilege of wearing letters of any kind, including: lavalieres, sweatshirts, or t-
 - b. shall not be allowed to vote, attend meetings, participate in blackball proceedings, pledge activities, or bid turn-in
 - c. may be invited to attend sorority social events with a three-fourths approval of the sisters
 - d. may attain full membership by a three-fourths approval of the sisters, and by participating in honorary induction.
 - 5. The sisters of Kappa Phi Alpha extend honorary membership according to the following guidelines: a. can wear letters only
 - b. can attend all meetings, but cannot vote
 - cannot attend any meetings concerning rush or pledging
 - c. can attend sorority function

- d. may only be considered for honorary membership under extreme circumstances
 - the faculty advisor of the Greek Council must deny this person the opportunity to rush because of medical illness or some other extending circumstances

e. must be suggested at blackball and approved in the same manner as a rushee.

The brothers of Phi Gamma Phi extend honorary membership by the following guidelines:

a. must be approved unanimously

b. may be voted upon at any time.

- The brothers of Pi Delta Chi extend honorary membership according to the following guidelines:
 - Honorary members shall consist of those affiliated with the college, whom the fraternity deems worthy of honorary membership due to outstanding circumstances, such as; inability to complete pledging due to illness, death in the family, etc. If only one rushee turns in a bid, he will automatically be considered a honorary member until he completes pledge activities with the

The sisters of Pi Sigma Kappa extend honoraries full membership.

The brothers of Sigma Alpha Kappa extend honorary membership according to the following

a. cannot hold office when they are honoraries

b. have the option to become full brothers of the fraternity after an initiation period

- c. after the initiation period, honorary status will be changed to that of a full brother and they will be able to hold office, pay dues, etc.
- 10. The brothers of Sigma Iota extend honorary membership according to the following guidelines:

a. must be approved unanimously by the fraternity

- b. may become a full brother by completing pledging activities according to the Greek Council's initiation period.
- 11. The sisters of Sigma Upsilon Nu extend honorary membership in which honoraries have all the rights and privileges of an active sister. Honorary members shall not be required to attend meetings or pay dues. Honorary members may be selected from the faculty or community by unanimous vote of the
- 12. The brothers of Theta Chi Epsilon extend honorary membership according to the following guidelines: a. must have a sufficient reason to be unable to rush in the normal process
 - shall have membership and voting privileges of full members except for the right to hold office.

The Greek Council must deal with all issues of honorary status and membership, as necessary for Council business, guided by individual organization definitions and deciding on a case-by-case basis."

-Article III, Section 4 shall read:

Any member, as defined in Greek Council By-Laws section 8, part B, sub-parts 1-13, who is eligible to carry an organizational charter or sit on Greek Council, must pay dues to the Council, as set each semester."

-Article VI, Section 1 shall read:

Any student who has previously accepted a bid from an Emory & Henry Greek social organization shall not be eligible for any rush or pledging activities of any other Greek social organizations at Emory & Henry College."

The following are the sections in question...

By-Laws, Section 8: Honoraries

A. The Greek Council will reserve the right to limit the number of honoraries that may be awarded by any one organization.

Article III, Section 4: Membership Dues

A. Each Greek member shall pay membership dues to the Greek Council each semester.

B. The Greek Council will be responsible for setting the dollar amount of these dues. The Greek Council must decide on the dollar amount of these dues by the end of the preceding semester.

C. Each participating Greek organization will be responsible for collecting and turning in these dues no later than one month into each semester. The failure of an organization to pay these dues will result in

the organization receiving non-active status in the Greek Council until dues are paid. D. All membership dues shall be used for conducting official Greek Council business.

Article VI, Section 1: Rush

- A. The Greek Council and the Rush Committee shall oversee the operation of two rush programs a year.
- B. The Greek Council shall set the appropriate fee for Rush Sign-Ups.
- C. The Rush Committee shall set the dates for Rush Sign-Ups one semester in advance.
 - 1. No student will be allowed to sign-up for Rush after the end of the specified sign-up period.
 - 2. The Greek Council may extend Rush Sign-Ups as it sees necessary.
- D. The Greek Council Treasurer shall receive all funds collected during the administration of Rush 1. These funds shall be utilized as specified by the Greek Council.
- E. The Greek Council shall assign Rush Dinner dates on a rotating basis.
- F. Students who rush first as a Sophomore, Junior or Senior shall be eligible to rush a total of two times.
- G. Any student with Sophomore standing who has completed at least twelve credit hours at Emory & Henry with a cumulative GPA of 2.0 shall be eligible for rush.
- H. 1st Year Rush and Pledging
 - 1. All 1st year Students who have accumulated at least 12 credit hours at Emory & Henry College, and maintained a cumulative GPA of at least 2.75 shall be eligible for Greek Rush.

2. Any student who chooses to rush during the second semester of their 1st Year will be afforded no more than three opportunities to rush.

3. The subject of inviting 1st Year Students to participate in rush activities and/or pledging will be left to the discretion of each organization. No organization may be forced to accept 1st Year Students. 1st Years should be made aware that not all Greek Organizations will accept them.

This section (governing 1st Year Rush) shall be effective for a trial period from Spring 2000 until the end of the Spring 2001 academic term.

SENATE BILL #41

The following is a measure to amend the Constitution.

Be it enacted by the Senate of Emory & Henry College,

Amendment IV - Judicial Branch

In an effort to allow and encourage students to take the greatest possible responsibility for the behavioral standards of this community, this Student Government Judicial System is hereby established. The Student Government Judicial System shall consist of the Central Judicial Council and a system of inferior judicial bodies as the Senate may, from time to time, establish.

I. Central Judicial Council

A. Structure

- 1. The Central Judicial Council shall be the final student authority in all campus judicial/honor matters, within the jurisdiction established by this Student Government Code and applicable College Policy. It shall also be the final authority on interpretation of the Student Government Constitution.
- 2. This body shall be composed of five student councilors appointed by the President of the Student Body with the advice and consent of the Senate, one faculty councilor elected by the faculty and one administrative councilor appointed by the President of the College. Terms for all Student Councilors shall be for the academic year. Terms for the Faculty Councilor shall be determined by the faculty. Terms for the Administrative Councilor shall be determined by the President of the College. The President and Vice President of the Student Body shall serve as ex-officio members of the Council, with all rights of members, except that of the vote. One of the student members of the body shall be appointed by the Student Body President with the consent of the Senate, to serve as the Chief Councilor, who shall be responsible for formally convening the Council, and to moderate the proceedings of any hearings or deliberations of the Council.
- 3. No less than two Alternate Student Councilors shall also be appointed by the President of the Student Body, with the consent of the Senate, to serve as substitutes any time a regular Councilor must be absent. When a Councilor must be excused from a hearing, the Chief Councilor shall be present for any hearing to take place.
- 4. First year students and first-term transfer students shall be ineligible for membership on the Council. No student may serve who is currently under any form of probation or whose grade point ratio falls below 2.00. The student government shall make every effort to appoint Councilors who have a GPA of at least 3.00.
- 5. Members may be re-appointed.
- 6. In case of a vacancy in a Student or Administrative Councilor position, the appointing body shall act within 10 working days to effect a replacement. In the case of a faculty vacancy, the faculty shall elect a replacement at the next scheduled faculty meeting. In the interim period, the Dean of The Roard shall elect a country of the property of the faculty.
- 7. The Board shall elect a secretary from among its members, who shall be responsible for keeping records of all Council proceedings in collaboration with the Dean of Students Office.



B. Jurisdiction

The Central Judicial Council shall have the final jurisdiction within the Student Government's Judicial System. The scope and practice of the original and/or appellate jurisdiction of the Council shall be determined from time to time by the College Senate. This authority shall extend to all matters of student discipline, including the Code of Conduct established by the College and any other systems of regulations created or implemented by the Student Government (i.e. Honor Code) as defined by the Senate.

2. The Central Judicial Council shall have jurisdiction to rule on any question of interpretation of the Student Government Constitution that may be presented to it by any elected official of the Student Government. Such official rulings of the Council shall be binding upon any/all officials of the Student Government. No other body within the Student Government shall have this authority.

II. Subordinate Judicial Bodies

All subordinate judicial bodies shall be established by the Senate through regular legislation. As part of this authority, the Senate is required to establish both the structure of the subordinate judicial system, and the procedures for all hearings and appeals.

SENATE BILL #42

This hereby amends the Judicial Code.

Be it enacted by the Senate of Emory & Henry College,

Emory & Henry College Judicial Code

Emory & Henry College Student Government seeks to provide an atmosphere in which intellectual, religious, moral, and social growth may take place and thus assist the student toward personal fulfillment and responsible participation in the modern world. To this end, the College seeks to insure freedom of inquiry and expression in teaching and learning. Since experience in total community is a part of the teaching-learning process, this freedom depends upon the appropriate opportunities and conditions in the classroom, on the campus, and throughout the College community. The administration, faculty, and Student Body therefore, have basic responsibilities toward realizing the purposes of Emory & Henry College through establishing programs and policies and setting standards of scholarship and conduct which are appropriate to these objectives.

Expectations of student conduct are defined in various College publications as well as communicated through groups and organizations of the College community by meetings, publications, and contracts. It is the student's obligation to conduct himself/herself as a responsible citizen, to abide by the stated rules and regulations of the College and to express himself/herself in an orderly manner.

Since the responsibility to secure and to respect general conditions conducive to the freedom to teach and to learn is shared by all members of the academic community, the statement of the judicial policies and procedures outlined below has been developed jointly by the students, faculty, and administration of Emory & Henry College. It is assumed that if these procedures are followed, the student will be protected from any unfair imposition of penalties and the purposes of the College will be more nearly realized.

The Judicial Structure

- I. Social Discipline Adjudication of Code of Conduct Violations
 - A. Initial Jurisdiction
 - 1. Social Discipline Council (Minor)
 - a. The Social Discipline Council (Minor) shall be charged with initial jurisdiction over cases where possible sanctions are less than suspension or expulsion.
 - b. The Social Discipline Council (Minor) shall be composed of three students, appointed for a term of one academic year by the President of the Student Body with the consent of the Senate. If one or more of the Councilors is unable to hear a case, then the Student Body President shall appoint a temporary replacement for that case, with the advice and consent of the Dean of Students.
 - c. The President shall designate one of the three student Councilors to serve as Chief Councilor of the body. The Chief Councilor shall chair all proceedings of the body



with the advice and counsel of the Hearing Officer. The Chief Councilor shall retain the right to vote as a part of Council proceedings.

- d. The Dean of Students shall appoint an administrative Hearing Officer to advise the Council. This person's role shall be to advise the Chief Councilor on hearing procedure; to meet with all accused students before hearing and explain the charges, their rights, and their options; to schedule cases for hearing; and to maintain records of all Council proceedings. The Hearing Officer shall also be responsible for ensuring that the developmental needs of the involved students are being met through the judicial process, and if necessary, petition for an administrative hearing in cases where it is developmentally appropriate.
- e. First year students and first-term transfer students shall be ineligible for membership on the Council. No student may serve who is currently under any form of probation or whose grade point ratio falls below 2.00. Every effort should be made to ensure that Councilors at all levels of the judicial process are exceptional students and upstanding members of the community.

2. Social Discipline Council (Major)

- a. The Social Discipline Council (Major) shall be charged with initial jurisdiction over cases where possible sanctions may include suspension or expulsion.
- b. The Social Discipline Council (Major) shall be composed of five Councilors, three students, one faculty member, and one administrator. The Student Councilors shall be appointed for a term of one academic year by the President of the Student Body with the consent of the Senate. The Faculty Councilor shall be elected by the faculty, to serve a term that the faculty shall determine. The Administrative Councilor shall be appointed by the President of the College for a term that the President of the College shall determine.
- c. If one or more Student Councilors is/are unable to serve for a particular case, the President of the Student Body shall appoint a temporary replacement for that case with the consent of the Dean of Students. There shall be not less than one alternate faculty Councilor elected by the faculty, who shall serve if the primary Faculty Councilor is not able to hear the case. There shall be an alternate administrative Councilor designated by the President of the College to serve if the primary Administrative Councilor is not able to hear a case.
- d. The President of the Student Body shall appoint one of the three Student Councilors to serve as the Chief Councilor. The Chief Councilor shall chair all proceedings of the body with the advice and counsel of the Hearing Officer. The Chief Councilor shall retain the right to vote as a part of Council proceedings.
- e. The Dean of Students shall appoint an administrative Hearing Officer to advise the Council. This person's role shall be to advise the Chief Councilor on hearing procedure; to meet with all accused students before hearing and explain the charges, their rights, and their options; to schedule cases for hearing; and to maintain records of all Council proceedings. The Hearing Officer shall also be responsible for ensuring that the developmental needs of the involved students are being met through the judicial process, and if necessary, petition for an administrative hearing in cases where it is developmentally appropriate.
- f. First year students and first-term transfer students shall be ineligible for membership on the Council. No student may serve who is currently under any form of probation or whose grade point ratio falls below 2.00. Every effort should be made to ensure that Councilors at all levels of the judicial process are exceptional students and upstanding members of the community.

3. Administrative Hearing Option

- a. The Student Government recognizes that, as a community of learning, the developmental interests of Emory & Henry Students is a primary concern. Therefore, in instances where an administrative hearing is developmentally appropriate, or necessitated by the absence of a quorum of the appropriate Discipline Council, an administrative hearing may be conducted.
- b. If, in the opinion of the Hearing Officer, it is developmentally crucial to an involved student, s/he may petition for an administrative hearing in the following manner:
 - i. The Hearing Officer shall contact the Dean of Students and present the pertinent information about the case to the Dean.
 - ii. If the Dean of Students agrees that an administrative hearing is essential, the hearing shall be scheduled administratively. It shall be emphasized, however, that administrative hearings shall only be conducted when it is essential to the developmental interests of the student.
 - iii. The administrative hearing shall be conducted by a Hearing Officer appointed by the Dean of Students.

B. Appellate Jurisdiction

1. Social Appellate Council

- a. The Social Appellate Council shall be charged with initial appellate jurisdiction over matters adjudicated by both of the Social Discipline Councils, and any administrative hearings.
- b. The Social Appellate Council shall be composed of three Councilors; two Student Councilors appointed for a term of one academic year by the President of the Student Body, and one faculty Councilor selected by the faculty for a term that the faculty shall establish.
- c. In the event that one of the Councilors is unable to hear a case, then the appointing/electing body shall be responsible for selecting a suitable alternate.
- d. The President of the Student Body shall appoint, with the consent of the Senate, one of the Student Councilors to serve as Chief Councilor of the body. The Chief Councilor shall chair all proceedings of the body according to the procedures outlined in this document. The Chief Councilor shall retain the right to vote as a part of Council proceedings.
- e. In the event that an appeal must be heard during the summer session, the appeal shall be presented to the Provost and Dean of Faculty. In the case of appeals during the summer session, the decision of the Provost and Dean of Faculty shall be final.

2. Central Judicial Council

- a. The Constitutional Central Judicial Council shall be the final appellate jurisdiction within the Student Government's Judicial System. It shall be the second and final appeal within said system afforded to accused students.
- b. The Central Judicial Council shall be constituted as provided in Amendment IV of the Student Government Constitution.

II. Academic Discipline - Adjudication of Honor Code Violations

A. Evidence Review Committee

- 1. Cases investigated for Honor Hearings shall be presented to a Evidence Reveiw Committee composed of three persons: the Chair of the Faculty Academic Standards Committee, and two other members of the committee (one student and one additional faculty).
- A majority of the Evidence Reveiw Committe shall be sufficient to find cause for a full Honor Hearing.

B. Honor Council

- 1. The Honor Council shall be charged with initial jurisdiction over all Honor Cases.
- 2. The Honor Council shall be composed of five Councilors, three students, one faculty member, and one administrator. The Student Councilors shall be appointed for a term of one academic year by the President of the Student Body with the consent of the Senate. The Faculty Councilor shall be elected by the faculty, to serve a term that the faculty shall determine. The Administrative Councilor shall be appointed by the President of the College for a term that the President of the College shall determine.
- 3. If one or more Student Councilors is/are unable to serve for a particular case, the President of the Student Body shall appoint a temporary replacement for that case with the consent of the Dean of Students. There shall be not less than one alternate faculty Councilor elected by the faculty, who shall serve if the primary Faculty Councilor is unable to hear the case. There shall be an alternate administrative Councilor designated by the President of the College to serve if the primary Administrative Councilor is unable to hear a case.
 - 4. The President of the Student Body shall appoint one of the three Student Councilors to serve as the Chief Councilor. The Chief Councilor shall chair all proceedings of the body with the advice and counsel of the Hearing Officer. The Chief Councilor shall retain the right to vote as a part of Council proceedings.
 - 5. The Dean of Students shall appoint an administrative Hearing Officer to advise the Council. This person's role shall be to advise the Chief Councilor on hearing procedure; to meet with all accused students before hearing and explain the charges, their rights, and their options; to schedule cases for hearing; and to maintain records of all Council proceedings.
 - 6. First year students and first-term transfer students shall be ineligible for membership on the Council. No student may serve who is currently under any form of probation or whose grade point ratio falls below 2.00. Every effort should be made to ensure that Councilors at all levels of the judicial process are exceptional students and upstanding members of the community.
 - 7. There shall be no option for administrative hearings in Honor Cases, except during the summer session. During this time, the Dean of Faculty, or his/her authorized representative(s), shall hear the case, and provide for a just and expedient appeals process.

C. Appellate Jurisdiction

- 1. Honor Appellate Council
 - a. The Honor Appellate Council shall be charged with initial appellate jurisdiction over matter adjudicated by the Honor Council.
 - b. The Honor Appellate Council shall be composed of three Councilors; two Student Councilors appointed for a term of one academic year by the President of the Student Body, and one faculty Councilor selected by the faculty for a term that the faculty shall establish.
 - c. In the event that one of the Councilors is unable to hear a case, then the appointing/electing body shall be responsible for selecting a suitable alternate.
 - d. The President of the Student Body shall appoint, with the consent of the Senate, one of the Student Councilors to serve as Chief Councilor of the body. The Chief Councilor shall chair all proceedings of the body according to the procedures outlined in this document. The Chief Councilor shall retain the right to vote as a part of Council proceedings.

- e. In the event that an appeal must be heard during the summer session, the appeal shall be presented to the Provost and Dean of Faculty. In the case of appeals during the summer session, the decision of the Provost and Dean of Faculty shall be final.
- D. Central Judicial Council
 - 1. The Constitutional Central Judicial Council shall be the final appellate jurisdiction within the Student Government's Judicial System. It shall be the second and final appeal within said system afforded to accused students.
 - The Central Judicial Council shall be constituted as provided in Amendment IV of the Student Government Constitution.

III. Procedures


- A. All judicial procedures shall take care to protect the rights of students, provide due process, and ensure swift and just judicial action.
- B. Procedures for Social Discipline Cases shall be established by the Executive in collaboration with the Dean of Students.
- C. Procedures for Academic Discipline Cases shall be established in the same manner as (B) above, but shall be consistent with the original procedures passed by the faculty, unless the faculty approve the pertinent changes.

IV. Administrative/Faculty Review

- A. In Social Discipline cases, the President of the College, or his/her authorized representative shall have the authority to review decisions of the Student Judicial System at any time.
- B. In Academic Discipline cases, the President of the College, his/her authorized representative, or an appropriate committee of the faculty shall have the authority to review decisions of the Student Judicial System at any time.

SENATE BILL #44

This hereby amends and supercedes Senate Bill #5.

Be it enacted by the Senate of Emory and Henry College,

Section I.

- A. Purpose The Department of Judicial and Honor Affairs shall have two purposes, encompassed in two different offices:
 - 1. The office of Honor Affairs shall serve to ensure the efficient and effective operation of the Honor Code of Emory and Henry College.
 - 2. The Office of Judicial Affair shall serve to ensure the efficient and effective operation of the judicial system in social disciplinary cases.
- B. Structure The Department shall be composed of three to five students selected from the student body as well as advisors from the faculty and/or staff. Each student selected must have at least a 2.0 GPA.
 - 1. The advisor for the Office of Honor Affairs shall be an administrative officer appointed by the Dean of Faculty.
 - 2. The advisor for the Office of Judicial Affairs shall be the Dean of Students.
 - 3. To the extent possible, an informal advisory relationship should be maintained with interested professors in the History and/or Political Science Departments.

Section II.

- A. Judicial and Honor Affairs Positions
 - 1. The Department shall be headed by the Judicial and Honor Affairs Officer. This Officer shall be the principle executive officer of the Department. He/She shall be appointed by the Student Body President with the advice and consent of the Senate.
 - 2. There shall be at least one Assistant Officer appointed for Judicial Affairs, and at least one appointed for Honor Affairs. These Assistants shall be appointed by the Student Body President with advice from the Judicial and Honor Affairs Officer.



B. Accountability

- 1. The Judicial and Honor Affairs Officer shall be directly accountable to the President of the Student Body.
- 2. The Assistant Officers shall be accountable to the Judicial and Hone Affairs Officer.

C. Duties

- 1. All Honor Affairs Office members shall be charged with the duty of assisting in the education of the student body regarding the policies and provisions of the Honor Code. All Judicial Affairs Office Members shall be charged with the duty of assisting in the education of the student body regarding policies and provisions of the judicial system. This may include, for both offices, chairing class assemblies and distributing informational pamphlets to ensure that the members of the student body are properly informed.
- 2. All Department members shall be charged with the duty of compiling a list of potential student investigators from which the President shall select two students to investigate each alleged violation of the Honor Code or the judicial system. The list of potential student investigators can be utilized by both Offices. This list shall consist of a majority of first year students in order to effectively orient first years to the Student Government and to increase their involvement.
- 3. In the event of an alleged Honor Code violation or social disciplinary problem, the appropriate Department members shall assume the duty of training the student investigators that have been appointed by the President. Such training shall include, but may not be limited to: a) the proper methods of gathering evidence; b) the evaluation of sources; c) the importance of confidentiality; and d) the proper means of compiling a report of all findings to be submitted to the appropriate body.
- 4. In the event of conflicting interests or other extenuating circumstances, the Department members may also serve as investigators of an alleged Honor Code violation or social disciplinary problem, respectively. The two offices may assist each other whenever necessary, such as in the event of case overload within any one office.
- 5. All Honor Affairs Office members, in conjunction with the Student Body President, shall be responsible for assisting in the editing and proposing of revisions to the Honor Code to reflect any and all changes in the structure of the Student Government and the student body. All Judicial Affairs Office members, in conjunction with the Student Body President, shall be responsible for assisting in the editing and proposing of revisions to the judicial system.

- 6. The Judicial and Honor Affairs Officer shall be a member of the Cabinet, and should attend all Cabinet meetings. Assistant Officers may be asked to attend at the discretion of the Student Body President or the Judicial and Honor Affairs Officer.
- 7. The Judicial and Honor Affairs Officer is responsible for attending all regularly scheduled College Senate Sessions. Assistant Officers may be asked to attend at the discretion of the Student Body President or the Judicial and Honor Affairs Officer.



Senate Bill No. 54

This legislation enacts a policy of equal opportunity for the Student Government, and the organizations that it charters.

Be it enacted by the Senate of Emory & Henry College,

- I. Non Discrimination Policy
 - As the Student Government of Emory & Henry College finds that discrimination in any form is contradictory to the advancement of the academic process, it has enacted the following policy of non-discrimination: The Student Government of Emory & Henry College, and every organization which it charters (save the exceptions cited in this document) shall not discriminate in membership, appointment to office, eligibility to stand for election, or in any other way on the basis of race, national or ethnic origin, sex, color, sexual orientation, religion, age, military service, disability, or disease status. This protection is intended to include students, faculty, and staff.
- II. Scope of Legislation
 - This legislation shall be binding upon all officers, members, advisors, and bodies of the Student Government; all officers, advisors and members of chartered student organizations (save the exceptions cited in this document); and any other aspect of student life under the direct jurisdiction of the Student Government. This does include organizations jointly sponsored by the Student Government and some other branch of the College. It is not intended as a measure to change the overall College policy of non-discrimination and has no effect thereupon, although the Student Government urges the College to adopt a more inclusive policy than it currently espouses. To further encourage a review of the College's policy of non-discrimination, following its enactment, official copies of this legislation shall be delivered to the President of the College, the Presiding Officer of the Faculty, and the Chairperson of the Board of Trustees by an authorized representative of the Student Government.
- III. Exemption/Special Status

In recognition of the longstanding tradition of some honorary academic fraternities and sororities, the social Greek fraternities and sororities, and certain other future organizations that may (at the time of chartering) be categorized by the Companizational under these regulations, the following conditional

exemptions are made:

- A. Honorary Academic Organizations: Such organizations (ex. Blue Key and Cardinal Key) shall be exempt from the part of the policy that forbids discrimination on the basis of sex, so long as similar organizations exist for both male and females.
- B. Social Greek Organizations: Such organizations shall be exempt from the portion of the policy that forbids discrimination on the basis of sex, so long as similar organizations exist for both males and females. Further, we recognize the historic prerogative that such organizations have exercised in determining their own standards for membership, and that such standards are not public information. And while we do recognize that these groups must be afforded special status, we do encourage them to abide by both the letter and spirit of this legislation. In light of this fact,
 - 1. Accept all of the obligations of this policy, including the following enforcement provisions, save the exemption of sex, in which case the status of the organization shall remain unchanged.
 - 2. Not accept the obligations of this policy, in which case the organization shall not be eligible to apply directly for any funding from the Student Government as other organizations do.

IV. Enforcement

The Student Government shall enforce this policy in the following manner:

- A. Complaints shall be filed with the Executive Branch (either the President or the Judicial/ Honor Affairs Department), or in the case of a complaint against the Executive Branch, the complaint shall be forwarded directly to the Chief Councilor of the Central Judicial Council by the complainant. Complaints shall be confidential.
- B. The case shall be forwarded to the Central Judicial Council for consideration. The Council shall consider the evidence surrounding the complaint in any way it so chooses, and shall determine if an act of discrimination (as defined by this legislation) occurred.
- Getha Council finds that an act of discrimination did occur, then it shall impose sanctions upon the offender(s).
 - Individual sanctions can include: removal from position within the organization (unless the individual is a constitutional officer of the Student Government where some other procedure is defined for removal), fines, and or educational or service sanctions.
 - 2. Organizational sanctions can include: suspension of organization's privilege of operating on campus, recommendation for revocation of charter to the College Senate, fines, removal of officers, and or educational or service sanctions.
- D. The complainant's identity shall be kept confidential outside of the hearing. Only the complainant may choose to reveal his or her identity.

The findings of the hearing, however, shall be kept confidential at the discretion of the accused party. Failure to abide by this regulation shall constitute a breach of the Honor Code.



This legislation provides for sanctioning of Phi Gamma Phi Social Fraternity following the events of Alpha Beta Chi "Airband" on Thursday, April 19, 2001.

Be it enacted by the Senate of Emory & Henry College,

- I. Whereas Phi Gamma Phi Social Fraternity engaged in obscene and lascivious behavior at ABX "Airband" on the 19th of April 2001, while the fraternity was already on disciplinary probation, the College Senate is taking this action in responses to the concerns of the College Community.
- II. The behavior in question is deemed to be obscene, contrary to the educational mission of the Gollege, an incitement of violence against women, and unbecoming of the image that should be presented by the Greek System, and the student body as a whole.
- III. As the organization in question has a documented history of violations of College policy, and is chirrently on probation for a recent incident, the Senate is resolved that it can no longer allow said organization to tarnish the image of the College, its Student Body, or its Greek System. Therefore, the following actions is to be effective immediately:
 - A. Phi Gamma Phi's Organizational Charter is hereby suspended for the Fall 2001 academic term. Accordingly, the organization may not operate in any capacity on this campus, hold a seat on the Greek Council, induct any new members, or participate in any campus activity or event in any capacity as an organization during the term.
 - B. Barking any further incidents may be fully re-instated based on the reevaluation of the College Senate no earlier that January 1, 2002. At that time, only members who have been inducted previous to the suspension shall be considered as members of the organization.
 - C. In the spring term of 2002, the organization will be placed on probation for a period of one full academic semester. During the period of probation, the organization will be allowed to induct a number a pledges specified by the Greek Council, none of which may be 1st Year Students.
 - D. Any further action which is deemed, by the Senate, to be contrary to the aims and go of bettering the Emory & Henry College Community shall be grounds for an immediate and permanent termination of Phi Gamma Phi's Organizational Charter.

We also fully understand that suspending a charter is a serious action, and one we hope to avoid in the future. Although the Senate does not intend to make a habit of this type action, we find that the events in question cannot be ignored, and have thus required

I believe that a fundamental right of the assembled Greek organizations is to choose their officers and representatives in a purely democratic manner. Time served prerequisites for officers on the council creates a situation in which the Greeks may be forced to have an officer that they do not support or endorse.

While there are many positive points to requiring people to have previously served in order to ensure competency, that is a barrier to democracy that we must not cross. We do not expect a Student Body President to have served in the Senate, Judiciary, or the Cabinet – and if we do not expect such from our Student Government leaders, we are wholly incorrect in expecting it from the Greek Council.

Be it enacted by the Senate of Emory & Henry College,

This legislation hereby amends and supercedes College Senate Bill # 15.

The following shall replace sections II and III of the Policy for Student Organizations:

II. Regulations governing Greek Rush and Pledging.

- A. All students with sophomore standing that have earned at least 12 credit hours at Emory & Henry College, and maintained a cumulative GPA of at least 2.0 shall be eligible for Greek Rush.
- B. All 1st Year Students who have earned at least 12 credit hours at Emory & Henry College, and maintained a cumulative GPA of at least 2.5 shall be eligible for Greek Rush.
- C. Any student who chooses to rush for the first time during their Sophomore, Junior, or Senior years may rush no more than twice.
- D. Any student who chooses to rush during the second semester of their 1st Year will be afforded no more than three opportunities to rush.
- E. Theisubject of inviting 1st-Year Students to participate in rush activities and/or pledging will be left to the discretion of each organization. No organization may be forced to accept 1st-Year Students. 1st-Years should be made aware that not all Greek Organizations will accept them.
- F. The Greek Council shall develop pledge/rush schedules in consultation with the Executive Branch of the Student Government. Approved pledge periods shall not exceed seven calendar days, excluding weekends.
- G. The names of all pledging coordinators shall be available to the Administration and the Student Government.
- H. Greek Organizations may schedule college facilities for use by pledges for study hall or pledging activities.
- I. Pledging must not interfere with the academic progress of pledges or members. Pledges must have access to the library without interference of pledge activities.
- J. A!! 2' doing activities must be approved by the Dean of Students prior to Pledge Week.
- K. The academic performance of First-Year Students who participate in Greek Rush/Pledging shall be reviewed annually by the Greek Council, Dean of Students, and Student Government in order to ensure that such activities do not harm the academic performance of said students.

III. Responsibility of the Student Government for rush and pledging.

The Executive Branch of the Student Government, through the supervision of the Greek Council, shall be responsible for oversight of rush and pledging regulations, and shall report any violations thereof to the appropriate judicial officials.

- I. The meeting days of The College Senate shall be October 15th, October 29th, November 19th, January 14th, February 11th, March 18th, April 8th, and April 22nd.
- II. The rule requiring a Senate Meeting each month shall be suspended for the month of December in the interest of time and scheduling of the Senators.
