Senate Bill # 75

The following is a measure to amend the Constitution.

Be it enacted by the Senate of Emory and Henry College, a vote by the College Faculty, and a student referendum

This hereby establishes the Procedures and Guidelines for the Emory and Henry Student Government Presidential Elections.


Section 1.

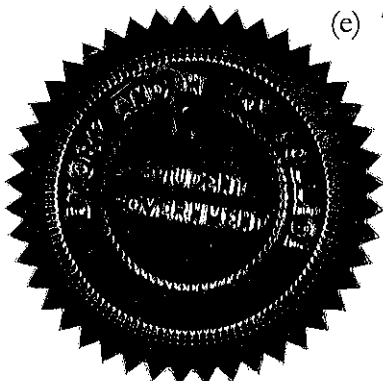
- (a) Purpose-- to ensure consistency in the student government presidential elections, to give candidates adequate campaigning time, to allow the campus media full coverage of the election, and to guarantee that the student body of Emory and Henry College will have adequate knowledge of the candidates and their platforms to make an informed selection.

Section 2.

- (a) The Student Government Presidential elections will be held in April, with the deadline to turn in nomination forms set as the first Tuesday in April.
- (b) A public debate, which will include an opening speech, will be held on the second Tuesday of April. Any candidate who would otherwise qualify for the ballot but does not participate in this debate shall be disqualified from any consideration for the office of President. The Dean of Students Office in conjunction with the current Elections Officer will formulate the time, place and format of the event in conjunction with the candidates.
- (c) Voting days should be scheduled for the Wednesday and Thursday of April immediately following the third Tuesday of April, two weeks after the deadline for nominations.
- (d) If, and only if, the preceding election schedule becomes impossible to follow due to unforeseen circumstances or scheduling conflicts, the Dean of Students Office in conjunction with the current Elections Officer will create a new schedule in conjunction with the candidates and the sitting President.
- (e) This amendment will take effect at the beginning of the 2002-2003 school year.

Senate Bill # 76

The following is a measure to amend the Constitution.

To be enacted by the Senate of Emory & Henry College, a vote by the College Faculty, and a student referendum.

This bill hereby establishes requirements and eligibility for Emory & Henry Student Government officials.


Section 1.

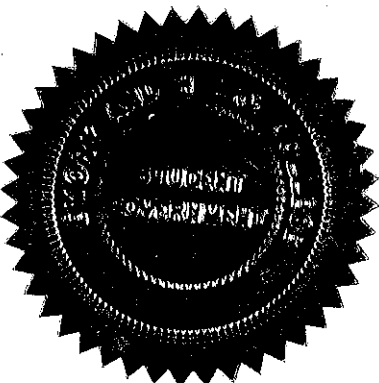
Purpose—to better define who is eligible for an Emory & Henry Student Government position.

Section 2.

- (a) In order to be eligible for the office of an elective student position, any person wishing to run for and retain that office must at all times during his/her term be a degree-seeking student of Emory & Henry College.
- (b) Any person wishing to run for the office of Senator must live in his/her respective district at the time of elections.
- (c) Any student elected official who is placed on any type of probation during his/her term of office would become ineligible for his/her position.
- (d) In the event that a Senator should become ineligible, this fact should be reported to the presiding officer and the Elections officer. The seat shall be declared vacant, and a special election shall occur as outlined in Article V, section D, subsection 2.
- (e) This Amendment will take effect at the beginning of the 2002-2003 school year.



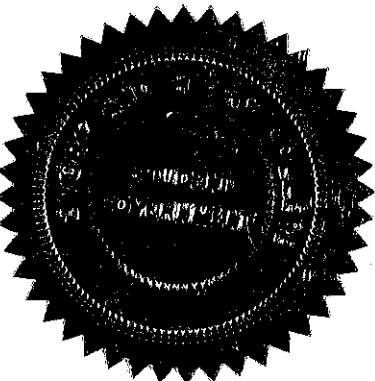
Senate Bill #77

Be it enacted by the Senate of Emory and Henry College,

- I. This bill hereby approves the attached Student Government budget for the Spring 2002 term.
- II. Stipulations to be placed on all accounts:
 - A. Any organization that uses Student Government funds for a fundraiser in the Spring 2002 term will be obligated to reimburse Student Government for this amount upon completion of that fundraiser.
 - B. If any organization that (including those awarded lump-sums) uses funds to pay for food, scrapbooks (including anything that would constitute as a scrapbook supply, such as film or film development), t-shirts, awards, or membership dues, that organization will **not** be reimbursed by Student Government, and will therefore be forced to pay for these items themselves, except for those organizations to which these funds have been stipulated in the budget.
- III. The Senate would encourage all organizations allotted funds to use the entire amount allotted to them this term. This Senate would also like to make a written request to the 2002-2003 Senate that if an organization is allotted funds for an item or event, and does not use those funds, then it should be strongly considered to cease funding of the said item or event in the future.

Senate Bill #78

Be it enacted by the Senate of Emory & Henry College,

This bill hereby provides guidelines for late budget requests and overspending by Senate-funded organizations.


- I. The Student Government President or his/her designated representative shall appoint the date and time of a budget request deadline. The due date must be communicated to each organization head at least three weeks prior to the request deadline through campus mail. In the event that a request is submitted late, it shall be considered after the requests turned in by the due date have been considered. In reviewing late requests, the submissions received closest to the specified deadline will be considered first.
- II. In order for the Senate to avoid over-spending by student organizations, the Student Government Treasurer shall not be permitted to give out more funds than the actual funds allotted to the organization as specified in the budget by the Senate Budget Committee.
- III. Exceptions to the foregoing provisions may be made under the following circumstances:
 - A. If the Senate Budget Committee feels that the punishments for late turn in presented would bring more loss than gain to the entire body of Emory & Henry College, then they are required to present these concerns to the Senate. The Senate can then vote by a 2/3 majority to allot the money requested, and this allotment must be documented along with specified reasons for this decision.
 - B. In the event that the Student Government Treasurer thinks that special circumstances justify that an organization should be reimbursed for overspending, he or she must present these concerns to the Senate. The

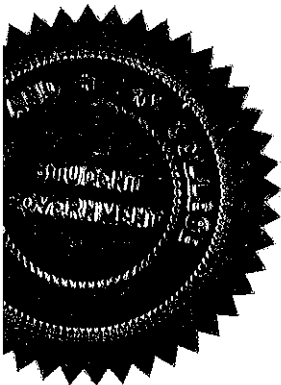

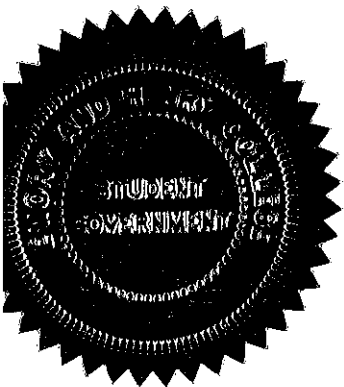

This bill hereby establishes the River's Way Organization.

Senate Bill #81


Be it enacted by the Senate of Emory & Henry College,

- I. The Senate reemphasizes what we concluded on April 25, 2001: “Whereas Phi Gamma Phi Social Fraternity engaged in obscene and lascivious behavior at ABX “Airband” on the 19th of April 2001, while the fraternity was already on probation, the College Senate is taking this action in response to the concerns of the College Community. The behavior in question is deemed to be obscene, contrary to the educational mission of the College, an incitement of violence against women, and unbecoming of the image that should be presented by the Greek System and the student body as a whole.”
- II. On the night of January 14th, this body passed bill #74 reinstating Phi Gamma Phi’s organizational charter with specific stipulations. The passage of this bill was contingent upon the members of Phi Gamma Phi’s agreement to follow the stipulations presented within the bill. It has now become clear that despite the agreement reached on the night of January 14th, Phi Gamma Phi has not met the stipulations of bill #74.
- III. The following stipulations have not been met by Phi Gamma Phi: Section V subsection a, Section V subsection c, Section V subsection d, and Section V subsection e. The Student Body President explained in person and in writing to Phi Gamma Phi social fraternity these stipulations, and there was ample opportunity to present questions and concerns about these stipulations during this process.
- IV. This body recognizes that it would be negligent on our behalf to overlook the preceding violations of bill #74, and so we resume the suspension of Phi Gamma Phi’s organizational charter with the following conditions:
 - a. With the exception of actions taken in an effort to meet the stipulations of Section V subsections a, c, d, and e in bill #74, Phi Gamma Phi does not exist as a chartered organization.
 - b. This organizational suspension will continue until December 2002, at which time the Senate will reevaluate Phi Gamma Phi’s standing with Emory & Henry College. It is highly recommended that members of the said

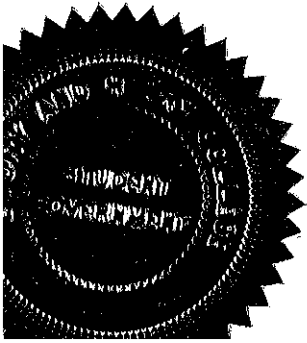
suspended organization make an effort to meet the stipulations previously mentioned.

- V. This action is being taken because on the night of January 14th, 2002, the members of Phi Gamma Phi unanimously agreed to abide by the stipulations set forth in bill #74. More than adequate guidelines on how to meet these stipulations were given, and unfortunately the stipulations were nevertheless violated.

Be it enacted by the Senate of Emory & Henry College,

The Senate reemphasizes that the charter of Phi Gamma Phi was revoked on March 18th, 2002, because the fraternity failed to comply with the guidelines it and the Senate agreed to in Senate Bill #74. Therefore, the purpose of this bill is to both provide clear and specific guidelines for the Senate to consider when it reviews the charter of Phi Gamma Phi in the Fall of 2002 and so that the said fraternity can know exactly what is required by the Senate in order to have its charter reinstated. If the fraternity fully completes the following requirements and is not involved in any other incidents which warrant action by Student Government, Greek Council, or the administration, the 2001-2002 College Senate recommends that the fraternity's charter should be fully reinstated upon its review by the 2002-2003 Senate without any further stipulations. For the purposes of this bill, anything that is required to be done in the fall semester of 2002 *must* be completed between the first day of classes and November 18th, 2002, in order for the Senate to consider it in its decision. In addition, the term "fraternity" is defined as having more than half of the active members of the organization present; if half of the active members are not present, then the Senate *will not* count this meeting as fulfilling one of the requirements of this bill.


These are the guidelines the 2002-2003 Senate is to use when it reviews the charter of Phi Gamma Phi social fraternity:

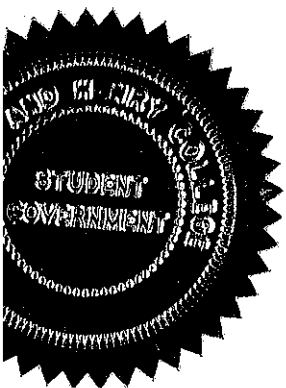
- I. The fraternity will meet with their advisor three times during the fall 2002 semester.
- II. The fraternity's faculty advisor will meet with the Phi Gamma Phi Senate Oversight Committee three times during the fall 2002 semester.
- III. The fraternity will meet with the Dean of Students three times during the fall 2002 semester. A meeting cannot occur within two weeks of a previous meeting in order to meet the requirements of this bill. (This is to prevent the fraternity from asking the Dean for a number of meetings to meet this requirement as the November 18th deadline approaches.)
- IV. Every active member of the fraternity will complete 25 hours of community service between the period of April 23, 2002 and November 18, 2002. No

community service may be undertaken without prior written permission from the Dean of Students. After any member engages in service to fulfill this requirement, written notification is to be given to the Dean of Students, the fraternity's faculty advisor, and the chair of the Phi Gamma Phi Oversight Committee stating the name of the member(s) that conducted the service, the date and time the service was completed, the location of the service, and what the service consisted of. (This is in no way designed to be an extensive report but merely one or two sentences that provide a record of what service was done so that the member's work can be documented.) This should be done shortly after the service is completed. All or part of this requirement *can* be fulfilled during the summer immediately preceding the fall semester.

- V. At least one member of the fraternity's officers will provide monthly progress reports to the Senate.
- VI. At the Senate meeting in which the fraternity's charter is to be reviewed, the organization will provide a report on the steps the fraternity has taken to complete the guidelines set forth in this bill. This will include the following: the number of times that the fraternity has met with their faculty advisor during the fall 2002 semester (and the advisor's signature that signifies his/her agreement); the number of times the fraternity's faculty advisor has met with the Senate Oversight Committee in the fall 2002 semester (again, with signature); the number of times the fraternity has met with the Dean of Students during the fall 2002 semester (and the Dean's signature that signifies his/her agreement); the number of hours of community service each member has completed since April 23, 2002, and what the service consisted of; and the number of progress reports that have been submitted to the Senate during the fall semester. This report is due at the Senate meeting (not before), but the fraternity must provide a copy of the report to all of the Senators, the Student Body President, the Student Body Vice-President, and the Dean of Students.

Section 3: *Sphinx*

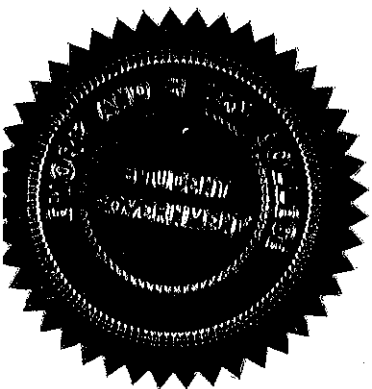
The editor of the *Sphinx* shall be Miss January Haile.


Be it enacted by the Senate of Emory & Henry College,

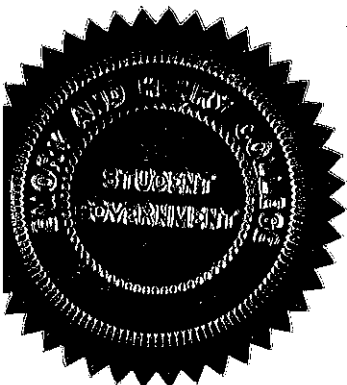
- I. This bill concerns reorganization in the structure that exists between the Campus News Media (*Whitetopper*, WEHC Radio) and the Student Government.
 - a. This bill hereby establishes a standing committee within the Student Government to be called the Media Advisory Committee (“Committee”). This Committee will be comprised of 3-5 members of the Senate and will be formed at the beginning of the academic school year alongside other Senate Committees. It will be the responsibility of this Committee to do the following things:
 - i. Communicate all student and Senate concerns regarding Campus News Media to the Media Governance Board (see section *b*) and act as liaison between the two.
 - ii. Make reports on personnel and financial issues to the Student Senate.
 - iii. The ultimate goal of this Senate Committee is to ensure the highest quality Campus News Media for the Emory & Henry community.
 - iv. Review the budget to be managed by the Media Governance Board.
 - b. The Senate recognizes that because of their unique organizational nature, complexity, and influence in the E & H community, the Campus News Media warrant a different approach to governance than other student organizations. This bill hereby establishes the Media Governance Board (“Board”). On this Board, each Campus News Medium will appoint their assigned Faculty Advisor, their manager/editor, and one other student member of their respective organizations. To encourage a non-biased perspective, the college Public Relations Director will also be on this board. This Media Governance Board will serve as an ancillary governing body so as to grant relative autonomy to the Campus News Media. Furthermore, so as to nurture an open line of communication between the students of Emory & Henry College and the Campus News Media, two Student Senators will be appointed to the Board by the Senate. The Board will be responsible for the following things:
 - i. The appointment and removal of Campus News Media personnel—including Editor/Manager—as necessary.
 - ii. Distributing funds—allotted to the Campus News Media in a lump sum—to both Campus News Media organizations as they deem

necessary. In addition, the board must do the following with regard to their finances:

1. Authorize expenditures of each respective Campus News Media organization.
 2. Supply a standard budget request to the Senate Finance Committee for the upcoming academic year.
 3. Keep detailed annual financial records of all funds and expenditures in order to assure fiscal accountability and responsibility to the student body.
 4. Submit an itemized annual report of previous academic year's expenditures before the start of the upcoming academic year to the President of the Student Body for distribution to the College Senate.
 5. To oversee the creation of partial self-funding through acquisition of sponsorships, underwriting, and advertisements where appropriate.
- iii. As the Board is the proximate governing body of the Campus News Media, they will be charged with setting quality levels for each medium and ensuring that those levels are maintained.
- II. This bill also clarifies, and in some cases changes, various procedural measures of the Campus News Media, the Media Governance Board, the Media Advisory Committee, and/or the College Senate. Changes/clarifications include:
- a. The Senate will allocate money to the Campus News Media as a single line item sum. Based on the Media Governance Board's academic year budget proposal, the Senate Finance Committee will determine a single line-item sum.
 - b. The Senate will no longer be responsible for the appointment and removal of editors/managers.
 - c. The changes herein represent major legislative action and thus necessitate the same for future adjustments.
- III. This Act will become effective in the 2002-2003 school year.
- IV. If at the end of two academic year (2003-2004), the parties to this arrangement find this system to be unworkable, they agree to submit to the arbitration of the President of the College as to whether or not this arrangement should be altered or renegotiated.

Communication to the Student Government President and the College Senate

Although I was not an active participant in the discussions prior to the presentation of Senate Bill 84 at the April 22, 2002, College Senate meeting, President Honeycutt informed me of the compromise he helped formulate between the Senate and representatives of *The Whitetopper* and WEHC-FM. President Honeycutt indicated to me that, although he has serious reservations about the changes made to the bill on the floor of the Senate, he felt he could not veto the bill as he had been a part of the compromise negotiations.

At its April 22nd Meeting, the College Senate waived its four-day rule for submitting bills in advance in order to consider extensive amendments to the proposed bill. The bill with amendments was fundamentally different from the original bill. The bill ultimately passed by the Senate appears to satisfy none of the parties involved. For example, the Senate vote by a wide margin did not guarantee a specified level of funding as provided in the original bill.

Moreover, the bill provided no reporting mechanism for the ways funds are used by the newspaper and radio station once the Senate gives funds to a proposed board. Finally, in the highly unlikely event of the removal of an editor or station manager, a conflict of interest has been created in that persons holding those positions would sit on the committee charged with the responsibility of removal.

The College Senate is completing its third year of operation. Senate Bill 84 fundamentally alters the role the Senate plays in campus life. At stake are fundamental issues about the role of the Senate and the role of campus media. I feel that it is in the best interest of all parties involved to veto this bill. Perhaps this action will provide a clean slate for next year's Senate to reopen discussions on this matter.

Senate Approval must be obtained for each Executive appointment.

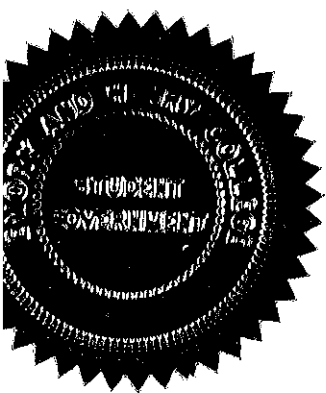

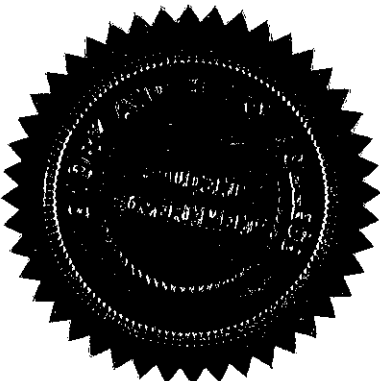
This bill hereby establishes the need for a two-thirds vote to suspend rules of the Senate.

Section 1.


The act amends the chart contained in Senate Bill #8, Section II to note that a two-thirds vote is necessary to suspend the rules of the Senate.

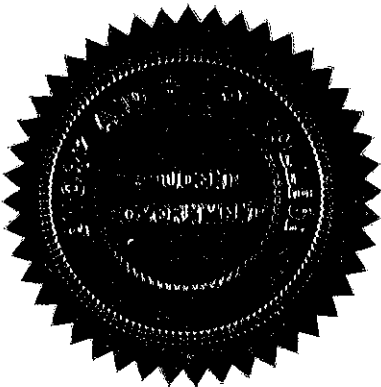



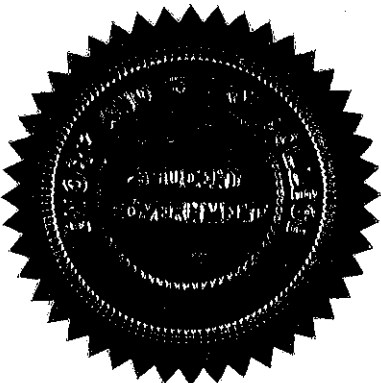
Be it enacted by the Senate of Emory & Henry College

This bill hereby approves the following amendments of the Alpha Psi Omega Constitution.

- I. Article II, Section 1, shall include the theatre Green Room as a location for posting information on pledging.
- II. Article II Section 3, shall note that only a maximum of twenty points for membership may be collected from a single production.
- III. Article II, Section 3, Subsection SPECIAL CATEGORIES, Number 4, shall include organization or club as a way to get points from being in a college drama organization.
- IV. Article II, Section 3, Subsection SPECIAL CATEGORIES, Number 5, shall state that speech classes will not count as completion of a working drama class.
- V. Article II, Section 5, shall establish that not more than 15 points for membership may be collected for work not directly related to stage or television production.
- VI. Article X, Section 2, Subsection A, shall include, "the semester prior to production", to establish when election of student directors will take place.
- VII. Article X, Section 3, shall include College Senate as a body to be included in the discussion of financial arrangements.
- VIII. Article X, Section 5, shall be changed to, "another faculty member", for the choosing of a new sponsor.
- IX. Article XI shall be added in its entirety to allow constitutional review by the organization on a scheduled basis.
- X. Article V, Section 9, shall be added that costumer will be an optional position.
- XI. Article II, Section 4, shall state that at least 20 points must be earned at Emory and Henry College.

This bill hereby amends the judicial code as stated in Senate Bill #42. In accordance with the preamble to the act that created the current Judicial System, the College Senate hereby reasserts that student self-governance is the surest and most legitimate means to guarantee orderly and honorable conduct among the student body. Since its enactment in April 2000, the current judicial structure has been the source of various inconveniences for students, faculty, and administration. Such inconveniences include but are not limited to: slow response time to deliberate hearings, limited amount of qualified applicants eligible for judicial appointment, imbalance between amount of cases heard and number of councils necessary to hear them. In order to create a more efficient and equitable form of adjudication at Emory & Henry College, this bill establishes a revised judicial structure.

Be it enacted by the Senate of Emory and Henry College

The Judicial Structure

- I. Evidence Review Committee
 - A. Cases investigated for Honor hearings shall be presented to an Evidence Review Committee composed of three persons: the Chair of the Faculty Academic Standards Committee, one student, and one additional faculty member. Neither the student nor the additional faculty member may serve on any judicial council.
 - B. The President of the Student Body with the approval of the Senate shall appoint the student member for a term of one academic year. The additional faculty member shall be elected by the faculty to serve a term that the faculty shall determine.
 - C. A majority of the Evidence Review Committee shall be sufficient to find cause for a full honor hearing.
- II. Initial Jurisdiction
 - A. The Judicial Board
 - i. The Judicial Board shall be charged with initial jurisdiction over cases where Code of Conduct violations and Honor Code violations have occurred.
 - ii. The Judicial Board shall be composed of ten councilors: six students, two faculty members, and two administrative members. The President of the Student Body with Senate approval shall appoint the Student Councilors for a term of one academic year. The Faculty Councilors shall be elected by the faculty to serve a term that the faculty shall determine. The President of the College shall appoint the Administrative Councilors to serve a term that the College President shall determine.

- iii. For cases involving social discipline where a Code of Conduct violation has occurred, the following shall apply:
 - 1. If the possible sanctions are less than suspension or expulsion, only three of the student councilors shall serve for the proceeding.
 - 2. If the possible sanctions include suspension or expulsion, only three student councilors, one faculty member, and one administrator shall serve for the proceeding.
 - 3. If the offense involves a traffic violation where an appeal has been submitted, each student councilor shall alternate as traffic hearing councilor for the monthly proceeding.
 - iv. For cases involving an Honor Code violation, only three student councilors, one faculty member, and one administrator shall serve for the proceeding.
 - v. If one or more student councilors is/are unable to serve for a particular case so that the number available is less than three, the President of the Student Body shall appoint a temporary replacement for that case with the consent of the Dean of Students. There shall be at least one alternate faculty councilor elected by the faculty who shall serve if the primary faculty councilors are unable to hear the case. There shall be at least one alternate administrative councilor appointed by the President of the College who shall serve if the primary administrative councilors are unable to hear the case.
 - vi. The Dean of Students shall appoint an administrative Hearing Officer to advise the Board according to the nature of a specific case. This person's role shall be to advise each hearing council on hearing procedure; to meet with all accused students before the hearing and explain the charges, their rights, and their options; to schedule cases for hearing; and to maintain records of all Council proceedings. The Hearing Officer shall also be responsible for ensuring that the developmental needs of the accused students are being met through the judicial process, and if necessary, petition for an administrative hearing in cases where it is developmentally appropriate.
 - vii. Student Councilors must be full time degree-seeking students who are not first year students or first-term transfer students. No student may serve who is currently on probation. No student may serve on the Judicial Board if they are a Resident Advisor or a member of the Executive Cabinet. Every effort should be made to ensure that Councilors at all levels of the judicial process are exceptional students and upstanding members of the community.
- B. Administrative Hearing Option**
- i. The Student Government recognizes that, as a community of learning, the developmental interests of Emory & Henry Students is a primary concern. Therefore, in social discipline instances where an administrative hearing is developmentally appropriate, or necessitated by the absence of a quorum of the Judicial Board, an administrative hearing may be conducted.

- ii. If, in the opinion of the Hearing Officer, it is developmentally crucial to an involved student, s/he may petition for an administrative hearing in the following manner:
 1. The Hearing Officer shall contact the Dean of Students and present the pertinent information about the case to the Dean.
 2. If the Dean of Students agrees that an administrative hearing is essential, the hearing shall be scheduled administratively. It shall be emphasized, however, that administrative hearings shall only be conducted when it is essential to the developmental interests of the student or during special times when it is not possible to convene a student board such as final exams, summer session, or in the event that no student alternates can be found.
 3. A Hearing Officer appointed by the Dean of Students shall conduct the administrative hearing.
- iii. There shall be no option for administrative hearings in Honor Cases, except during the summer session. During this time, the Dean of Faculty or his/her authorized representative(s) shall hear the case and provide for a just and expedient appeals process.

III. Appellate Jurisdiction

A. The Appellate Council

- i. The Appellate Council shall be charged with initial appellate jurisdiction over matters adjudicated by the Judicial Board and any administrative hearings.
- ii. The Appellate Council shall be composed of three councilors: two student councilors appointed for a term of one academic year by the President of the Student Body and one faculty councilor selected by the faculty for a term that the faculty shall determine.
- iii. In the event that one of the Councilors is unable to hear a case, then the appointing/electing body shall be responsible for selecting a suitable alternate.
- iv. Student Councilors must be full time degree-seeking students who are not first year students or first-term transfer students. No student may serve who is currently on probation. Every effort should be made to ensure that Councilors at all levels of the judicial process are exceptional students and upstanding members of the community.
- v. In the event that an appeal must be heard during the summer session, the appeal shall be presented to the Dean of Faculty. In the case of appeals during the summer session, the decision of the Dean of Faculty shall be final.

B. Central Judicial Council

- i. The Constitutional Central Judicial Council shall be the final appellate jurisdiction within the Student Government's Judicial System. It shall be the second and final appeal within said system afforded to accused students.
- ii. The Central Judicial Council shall be constituted as provided in Article VIII of the Student Government Constitution.


IV. Procedures

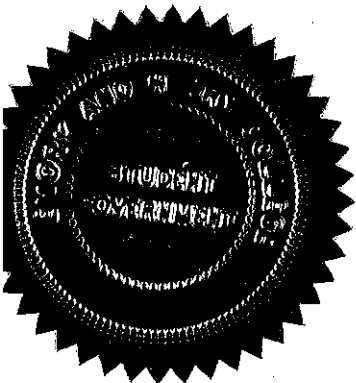
- A. All judicial procedures shall take care to protect the rights of students, provide due process, and ensure swift and just judicial action.
- B. The Executive in collaboration with the Dean of Students shall establish procedures for Social and Academic Discipline Cases upon approval of the College Senate. Additionally, Academic Discipline Cases shall remain consistent with the original procedures passed by the faculty, unless the faculty approves the pertinent changes.

V. Administrative/Faculty Review

- A. In Social and Academic Discipline cases, the President of the College, or his/her authorized representative shall have the authority to review decisions of the Student Judicial System at any time.

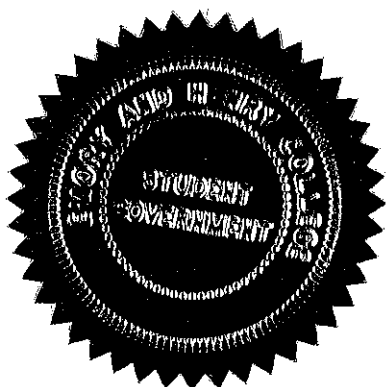



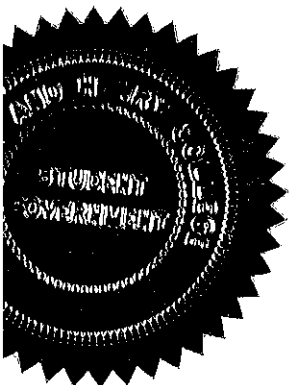

- VI. The Student Body President shall have the authority to appoint the interim manager of WEHC since no applications have been submitted for the position at this time.
- A. At the first meeting of the 2003-2004 College Senate, the President will nominate a student to serve as WEHC's manager. The Senate will vote whether to accept or decline the nomination of the President for this position.
1. If the Senate approves the President's nomination, the individual selected will remain manager of WEHC for the remainder of the year.
 2. If the President's nomination is not approved, the media committee will be charged with soliciting applications for the position and for interviewing the applicants; the committee will also be charged with making a recommendation to the Senate, in the form of a bill, as to who the manager of WEHC should be; this bill will then be voted on by the Senate.
- VII. This bill is to ensure that the selection of these individuals is not rushed and to give those who will fill them adequate time to work with the current editors/ managers of their respective organization.

Be it enacted by the Senate of Emory & Henry College, this resolution hereby clarifies the definitions of student organizations for official business of Student Government.

Whereas the present definition of student organizations for the official business of the Senate has been limited to the categories of “E&H Media,” “General Interest” and “Student Government,” and has had many variations in the names of those categories, and where the *2003-2004 Student Handbook*, published in conjunction with Student Government, recognizes eight categories of student organizations, those being “Student Government,” “Student Media,” “Interest Groups,” “Performing Groups,” “Honorary Groups,” “Religious Activities,” “Greeks,” and “Athletics,” and where there is no express definition for student organizations in Article II of the Constitution, it has become imperative to clarify for official business and legislation of Student Government the categories of student organizations.

Therefore be it resolved that the College Senate, sitting in formal session on this _____ day of _____, _____, does hereby approve the following changes in how Student Government defines and categorizes student organizations for all official business and legislation of Student Government conducted on and after the successful passing of this resolution.

- I. Let “student organizations” be broadly defined for official business and legislation of Student Government as any organization in “good standing” with Student Government. To be considered in good standing, a student organization must fulfill these minimum criteria:
 - a. Must have a faculty/staff advisor,
 - b. Must have a student Chief Executive Officer(s),
 - i. The CEO(s) must be selected and must govern the organizations’ operations as outlined in that organization’s charter,
 - c. Must resubmit its charter to Student Government every five years.

- II. A student organization may fall out of good standing with Student Government if any of the following should occur:
 - a. That organization does not adhere to its mission as outlined in its charter,
 - b. That organization fails to resubmit its charter after five years,

- c. That organization fails to elect a student CEO after a period of three semesters,
 - d. That organization is put on any form of probation.
- III. Those student organizations which are not in good standing with Student Government may not be formally recognized by Student Government and therefore may not receive financial support from Student Government. Should those organizations desire such support, they will have to resubmit their charters to Student Government as per the rules of the Policy for Student Organizations to come into good standing.
- IV. Student Government hereby further defines two categories of student organizations, those being “General Interest” and “Honorary Groups.”
- a. A student organization of “General Interest” is any organization which is in good standing with Student Government and whose charter outlines no restrictions or criteria for student membership.
 - b. For a student organization to be recognized as an Honorary Group, it must fulfill the following criteria:
 - i. That organization’s charter outlines restrictions on membership, those restrictions being, but not limited to:
 - 1. GPA,
 - 2. Major,
 - ii. That organization does not restrict membership based on social criteria.
- V. Student organizations of all categories must resubmit their charters to Student Government after making any changes to their charters which significantly alter the organization’s operations in order to operate on the campus of Emory & Henry College as directed in Section IV of the Policy for Student Organizations.
- VI. Should this act be approved by Student Government, all student organizations shall be required to file their charters with Student Government by the end of this academic semester to remain in good standing.




Be it enacted by the Senate of Emory & Henry College,

The passage of this bill hereby signifies the College Senate's approval of the petition for a 24-hour study lounge.

- I. The College Senate believes that a 24-hour study lounge is necessary on the Emory & Henry campus and believes that this petition accurately describes our belief in the importance of creating one on the Emory & Henry campus.
- II. Student Senators will circulate this petition to their constituents between October 29, 2003 and November 18, 2003. The Senate will compile all of the signatures supporting this petition at the Senate meeting on November 19, 2003.

Petition for 24-Hour Study Lounge

As a student of Emory & Henry College, the pursuit of knowledge and education is my primary concern. Because the library closes at midnight on weekdays and at 6:00 p.m. on Friday and Saturday evenings and academic buildings are typically locked during these times, students of different sexes have no place to study together. Furthermore, the activity in dorm lobbies often makes it impossible to study, and there are students on campus who do not own a computer. It is for these reasons that we, the undersigned, believe that there should be a 24-hour study lounge available on weeknights and weekends during the hours in which the library is closed. Furthermore, in order to appropriately address the needs of a college student, this study lounge should give students access to computers, a scanner, a printer, the internet, and the software necessary to complete class assignments. We believe that this request is reasonable and one that is consistent with Emory & Henry's purpose and motto.



Senate Bill #110

Be it enacted by the Senate of Emory & Henry College,

This bill hereby establishes the interim Media Commission.

- I. The purpose of the Media Commission will be to study the practices governing college media at Emory & Henry peer and aspirant institutions including, but not limited to, Guilford College, Hampden-Sydney College, Washington & Jefferson College, Bridgewater College, Mary-Washington College, Roanoke College, Randolph-Macon College, Sweet Briar College, Hollins University, and Virginia Wesleyan College.
- II. The members of the Media Commission will be as follows:
Representing the Administration: Dean Gourley and Greg McMillan
Representing the Staff: Dirk Moore
Representing the Faculty: Dr. S. Reid and Dr. Stovall
Representing the Media: Carey Alvanas and Ashley Susong
Representing Student Government: Courtney Bledsoe
Representing the Student Body: Erin Blankenship and Pati Parsley
- III. The Senate Media Committee will be responsible for delegating and collecting the research of the interim Media Commission as well as establishing intermediate deadlines. The Senate Media Committee will then analyze and report the information to the College Senate after each intermediate deadline whether this is at Senate meetings or through electronic correspondence. A final reporting recommendation from the Senate Media Committee shall be presented at the April 21st Senate Meeting.
- IV. The Senate Media Committee shall have the authority to add or replace members of the Media Commission.

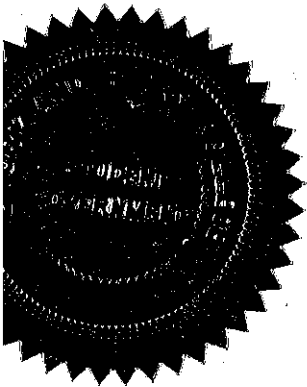


Be it enacted by the Senate of Emory & Henry College

This bill hereby signifies the College Senate's approval of the petition regarding the Internet situation.

- I. A petition shall be passed around the student body and available for every student to sign if they agree.
This petition shall state:
 - a. We, the following members of the student body of Emory & Henry College, hereby claim that we are unhappy with the Internet situation and the problems that it is creating for us as students. Because of the problems that Emory & Henry has faced this semester it has become difficult for us to do our homework to our professors' satisfaction and complete assignments. We would like to state that we are very unhappy with this situation and should it continue to occur/occur again, we want the community, including faculty and staff, to know how dissatisfied we are with the system.
 - b. We also want faculty and staff to understand that these conditions make it difficult to do our assignments, especially ones that are based solely upon the Internet. Therefore, we ask that faculty and staff have some lenience with students when it comes to assignments that require the assistance of the Internet.
- II. This petition shall remain on file with the student government and shall be available for everyone to view and for students to sign at any time they so wish.
