Projects

The SGA had previously proposed a total of three projects to be carried out over the course of the academic year. To date, two of the three have been completed.

1. Mural on The Merc Project

In December 2012, three talented E&H students: Cat Richardson, Brian Stanley, and Becky Sharkey, provided the leadership to complete the selected mural design with an environmental theme on the side of The Mercantile. It provides an attractive addition to our campus featuring work totally conceived and completed by our students.

2. Picnic Tables Project

In an effort to address the need for usable outdoor space on campus, the SGA commissioned shop class students from Patrick Henry High School to build three picnic tables which are now located on the grassy area between McGlothlin-Street and Miller Halls. We venture to guess that they will provide a popular and well utilized student space for breaks between classes.

3. Gate Restoration Project

Still in progress is the third project proposal to improve the landscaping in and around the E&H Class of 1927 gate near Hillman Hall. Its future completion will continue on our agenda.

College Senate

Fortunately, the amount of funding that SGA was allocated for the 2013 Spring Semester was increased when compared to last year's funding. As a result of this fact, the SGA will be able to finance more trips and events than we have seen in the past. The SGA is grateful for the monetary support from the College and the Board, and with this funding, students will continue to have positive experiences during their time here at Emory & Henry.

These changes call for the involvement of more than just students (the President of the College, the Board of Trustees, etc.), I believe it to be a step in the right direction. What is even better than this is the fact that students are coming together to try to resolve issues rather than taking it out on faculty, staff or other students.
